20 (Twenty) Year Limited Warranty

Definitions

“Palclad Pro Active Antimicrobial PVC Wall Cladding System” (hereinafter the “Product”) is hereby warranted by Palram Americas, Inc. (hereinafter the “Manufacturer”), subject to the terms contained herein.

Scope of Warranty

This warranty applies only to the party who owns (the “Owner”) the facility where the Product is installed when the Product is installed. In this warranty, “Owner” shall also mean a lessee or sub lessee who installs the Product or contracts to have it installed at a leased property which it occupies at the time of installation.

Manufacturer Defect Warranty

The Product shall:

- Not rot or corrode
- Remain structurally sound
- Remain non-conductive and non-flammable
- Remain free of manufacturing defects

(Hereinafter referred to as the “Product Defect”).

Commencement Date

The commencement date of this Warranty (the “Commencement Date”) shall be the date of the Product’s manufacture or, if such date does not appear on the Product, the date the Product was purchased from an authorized dealer or retailer.

Limitations

This warranty shall be valid only if:

The Product is used for purposes as specified by the Manufacturer.

The original proof of purchase is presented.

The Product is only used in a customary fashion, not exposed to weather or climatic elements and is stored, installed, handled, cleaned and maintained in accordance with the Manufacturer’s written instructions which are available on-line at www.palcladpro.com or by phone at 800.999.4959.

The Product is not warranted against natural disasters or color changes due to exposure to sunlight, artificial ultraviolet light sources, smoke, fumes or incompatible chemicals. See “Chemical Resistance of Palram PVC Products” in the downloads on www.palcladpro.com for a non-exclusive list of certain chemicals known to be incompatible with the Product. However, responsibility remains with the owner or end user to test for and determine chemical compatibility with the proposed application.

This warranty does not cover any costs and expenses of removal and installation of the Product or taxes or shipping cost or any other direct or indirect losses which may result from the Product Defect.

Claims and Notifications

Every warranty claim must be submitted in writing to the Manufacturer or original dealer promptly after occurrence of the Product Defect, enclosing the original sales receipt or other proof of purchase and this warranty. Owner may make only one claim under the warranty against the Product Defect for any particular installation over the lifetime of the Product. The claimant must allow the Manufacturer an opportunity to inspect any or all of the Product involved and the installation site itself while the Product is still in its original position and have not been removed, moved or altered in any way, or upon the Manufacturer’s request, return a sample of the sheets to the Manufacturer for testing. The Manufacturer reserves the right to investigate independently the cause of any failure.

Compensation

If a claim is covered under this warranty, the Manufacturer will provide the Owner with free replacement Product or, at the Manufacturer’s discretion, refund all or part of the original purchase price paid by Owner, in accordance with the Refund Tables listed below. Replacement Product is warranted only for the balance of the warranty on the original Product.

Refund Tables

Manufacturer’s Defect

If over a specific period of time the Product exhibits a Manufacturer’s Defect and the Manufacturer elects to make a refund rather than supply replacement Product, the

applicable refund percentages are as follows, based on the time elapsed from the Commencement Date to the time the loss is reported to the Manufacturer:

Jurisdiction

This limited warranty shall be governed by and shall be construed according to the laws of the Commonwealth of Pennsylvania, USA. Any claim or dispute related to the product and/or this warranty shall be exclusively brought before the appropriate court in the Commonwealth of Pennsylvania, USA, which shall have the exclusive jurisdiction in any such claim or dispute.

THIS LIMITED WARRANTY SHALL BE THE MANUFACTURER'S SOLE WARRANTY APPLICABLE TO THE PRODUCT. ANY OTHER CLAIMS FOR DAMAGE OR LOSS, DIRECT, INDIRECT OR CONSEQUENTIAL, WHATEVER THE CAUSE THEREOF, ARE EXPRESSLY EXCLUDED FROM THE WARRANTY. THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, WRITTEN

OR ORAL, STATUTORY, EXPRESSED OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS OF A PARTICULAR PURPOSE. UNDER NO CIRCUMSTANCE SHALL THE MANUFACTURER BE LIABLE FOR ANY AMOUNT GREATER THAN THE ORIGINAL PRICE PURCHASER PAID FOR THE PRODUCT.

Disclaimer
